PEDSnet named key partner in FDA Global Pediatric Clinical Trials Network proposal

With the endorsement of our [Steering Board](#) and the [PCORnet Pediatric Collaborative Research Group](#), PEDSnet has been named as a key partner in the [Institute for Advanced Clinical Trials for Children \(I-ACT\)](#)'s response to the [FDA Global Pediatric Clinical Trials Network RFP](#). I-ACT Chairman and President Dr. Ed Connor and team submitted the application earlier this week. The goals of this program are to support the development of the scientific infrastructure needed to plan and execute pediatric clinical trials through collaboration with stakeholders from academia, industry, parent/patient advocacy groups, and government agencies. If funded, with leadership from the [Anderson Center](#) at CCHMC and [ImproveCareNow](#), PEDSnet will use improvement methods to assist organizations in meeting trials qualification criteria and to continuously improve trial execution. PEDSnet sites will have the opportunity to participate in the development of a network of clinical sites for future clinical trials. PEDSnet will also lead data analyses using existing EHR, health plan, and registry data for trial feasibility.

Executive Committee supports MOU with the National Evaluation System for health Technology Coordinating Center (NESTcc)

Earlier this month the PEDSnet Executive Committee gave approval to offer a letter of support to the [Medical Device Innovation Consortium \(MDIC\)](#) for their renewal application of the FDA [National Evaluation System for health Technology Coordinating Center \(NESTcc\)](#). Serving as the NEST coordinating center, MDIC asked the PEDSnet Executive Committee, as a prospective strategic partner, to consider formally establishing a relationship between PEDSnet and the NESTcc with a [Memorandum of Understanding \(MOU\)](#). We are pleased to share that the EC voted unanimously to sign the Memorandum of Understanding earlier this week.

Demonstration Study Data Releases

Study data sets have been released and analyses are underway for two PEDSnet demonstration studies. The first is Dr. Jim Franciosi's [Unintended Consequences of PPI Use](#) based at Nemours and the second is Drs. Jason Lang and Tim Bunnell's [Defining Key Determinants on the Path from Obesity to Asthma in Children \(KOACH\)](#) also out of Nemours.

COMBINE Update

Dr. Peter Margolis and Lisa Boerger of the PEDSnet CCHMC team reported on regulatory and contracting metrics for the [COMBINE trial](#) at the August 11th PEDSnet Executive Committee meeting. On average it took 178 days for participating sites to obtain IRB approval, with 29 days being the shortest time to approval for a single site. Meanwhile, the shortest time to contract execution was 51 days, taking an average of 148 days across sites. Performance metrics will be presented to the EC on a monthly basis to gauge how PEDSnet is doing in relation to other networks, and to identify areas for improvement.

Computable Phenotypes Update

All PEDSnet sites are working diligently on the completion of **chart reviews** for each phenotype cohort, and are on track to meet deadlines for analyses and manuscript submissions.

Data Network Updates

Data Cycles

The PEDSnet [data network](#) is currently live with version 2.5 of the data, and we'd like to thank our sites' informatics teams who have all submitted their version 2.6 data for the upcoming cycle. In July, the network submitted and passed data characterization for [PCORnet 3.1](#). An update to the PCORnet data model included collecting additional labs per their requirements.

New Publication on LHS Core Competencies

PCORnet Antibiotics Study

Contracting, regulatory, and enrollment metrics for sites participating in the PCORnet Antibiotics and Obesity study are summarized [here](#). Analyses for Aim 2 (growth trajectories) and Aim 3 (maternal-child linkage) are in progress. Two manuscripts, one on cohort description and the other on early antibiotic use and association with pediatric obesity, are being submitted for publication. Abstracts for both papers have been submitted for presentation at the annual meeting of [The Obesity Society](#) in the fall.

CDM Expansion

The data network will begin discussions around **data model upgrades** starting in the fall with the aim to have them implemented in the new year.
